### 3. **Composition, Information or Ingredients**

### 4. **First Aid Measures**

**Eye Contact:** Check for and remove any contact lenses. Immediately flush eyes with clean, running water for at least 15 minutes while keeping eyes open. Cool water may be used. Seek medical attention.

**Skin Contact:** After contact with skin, wash with generous quantities of running water. Gently and thoroughly wash affected area with running water and non-abrasive soap. Cool water may be used. **Inhalation:** Remove the victim from the source of exposure to fresh, uncontaminated air. If victim's breathing is difficult, administer oxygen. Seek medical attention.

**Ingestion:** Do NOT induce vomiting. Give water to victim to drink. Seek medical attention.

### 6. **Accidental Release Measures**

Steps to be taken if material is spilled or otherwise released into the environment - Wear Appropriate respirator, impervious boots and heavy rubber (or otherwise impervious) gloves.
