### 3. Composition, Information or Ingredients

### 4. First Aid Measures

**Eye Contact:** Check for and remove any contact lenses. Immediately flush

**Skin Contact:** eyes with clean, running water for at least 15 minutes while keeping eyes open. Cool water may be used. Seek medical attention. ## 6. Accidental Release Measures

Steps to be taken if material is spilled or otherwise released into the environment - Wear Appropriate respirator, impervious boots and heavy rubber (or otherwise impervious) gloves.
