4. **First Aid Measures**

Ingestion:	Do NOT induce vomiting. Give water to victim to drink. Seek medical attention.

Extinguishing media:	Carbon dioxide, dry chemical powder, alcohol or polymer foam.

6. **Accidental Release Measures**
