### 4. First Aid Measures

Cover the affected area with emollient. Seek medical attention. Wash any contaminated clothing prior to reusing.

**Inhalation:** Remove the victim from the source of exposure to fresh, uncontaminated air. If victim's breathing is difficult, administer oxygen. Seek medical attention.

**Ingestion:** Do NOT induce vomiting. Give water to victim to drink. Seek medical attention.

## 5. Fire-Fighting Measures

## 6. Accidental Release Measures

Steps to be taken if material is spilled or otherwise released into the environment - Wear Appropriate respirator, impervious boots and heavy rubber (or otherwise impervious) gloves.
